# Conditions of Issue BBTCA RAIC, Access Passes & AVOP

# The Conditions of Issue of any airport pass:

- That the pass issued to me is the property of BBTCA;
- 2. That the pass issued to me is not to be used to bypass passenger pre-board screening where, as an intended passenger on commercial aircraft, I would be subject to such screening;
- 3. That the pass issued to me is subject to the limitations and restrictions set out on the face of the pass and to any other limitations issued to me in writing by the aerodrome operator;
- 4. That the pass issued to me has been designed to be worn on the outer clothing on the left or right side of the chest (or on the outer left or right upper arm when the chest location interferes with my ability to work) with the front of the pass visibly displayed
- 5. That I will safeguard the pass issued to me and if lost, stolen or damaged that I am subject to fees associated with the administration of the pass system as follows:

a. Pass lost 1<sup>st</sup> time: \$100.00 fine
b. Pass lost 2<sup>nd</sup> time: \$200.00 fine

c. Pass lost 3<sup>rd</sup> time: \$300 fine + No pass issued

**6.** That if I fail to return a Pass after my need and right no longer exists I will be charged \$300

- 7. That I am subject to the requirements of the Aerodrome Restricted Area Access Clearance Program, including the requirement for escort or other security controls where necessary
- **8.** That the pass issued to me shall be returned directly to the issuing authority (my employer or the aerodrome operator) immediately:
  - a. when I cease to work at the aerodrome
  - **b.** when my airport restricted area access clearance has been denied, suspended, revoked, cancelled or has expired
  - **c.** when I cease to require access to the restricted area for which the pass was issued
- 9. That I have read the relevant excerpts of the Canadian Aviation Security Regulations (CASR) and the Conditions of Issue and understand that failure to comply could result in confiscation of my pass and/or maximum monetary penalty of \$5000.00.
- 10. That as a Pass holder, I will not act in any way that reduces, interferes or may interfere with, compromises or may compromise as determined by BBTCA the safety and security of the airport, airport workers, tenants, air carriers, occupants, BBTCA or the general public

# **Excerpts from Canadian Aviation Security Regulations**

#### **False information**

303. A person must not provide false information for the purpose of obtaining a restricted area identity card.

#### Return of cards

314. (2) if a restricted area identity card has been deactivated, the person to whom the card has been issued must immediately return it to the operator of an aerodrome who issued it unless the card was surrendered in accordance with this Division or was lost or stolen.

#### Surrender on demand

332. (1) A person in possession of a restricted area identity card must, on demand, surrender it to the Minister, the operator of an aerodrome, a screening officer or a peace officer.

#### Display of restricted area identity cards (RAIC)

323. A person to whom a RAIC has been issued must not enter or remain in a restricted area unless they visibly display the card on their outer clothing at all times.

#### Disclosure or use of codes

327. (2) A person, other than the operator of an aerodrome or a person designated by the operator, must not disclose a combination code or personal identification code; or use another person's combination code or personal identification code.

#### Report of loss or theft

328. (1) A person to whom a restricted area identity card or a key has been issued must immediately report its loss or theft to their employer or to the operator of an aerodrome who issued the card or key.

## Restricted area identity cards (RAIC) - conditions of use

322. (1) A person to whom a RAIC has been issued must not enter or remain in a restricted area unless:

- **a.** they are acting in the course of their employment;
- **b.** the card is in their possession;
- **c.** the card is active;
- **d.** as applicable, they are in possession of a key that has been issued to them for the restricted area, or a combination code or personal identification code that has been assigned to them for the restricted area.

## **General prohibitions**

327. (1) A person must not:

- **a.** lend or give a restricted area identity card or a key that has been issued to them to another person;
- **b.** use a restricted area identity card or a key that has been issued to them to allow access to a restricted area at an aerodrome to another person without authorization from the operator of the aerodrome;
- c. intentionally alter or otherwise modify a restricted area identity card or a key unless they're the operator of an aerodrome or a person designated by the operator;
- **d.** use a restricted area identity card or a key that has been issued to another person;
- have in their possession, without reasonable excuse, a restricted area identity card or a key that has been issued to another person;
- use a counterfeit restricted area identity card or a counterfeit key; or
- g. Make copies of a restricted area identity card or key.
